

Cami-I Kebir Minaret in Paphos

PROJECT OVERVIEW

Study Start Date: November 2015

End Date: February 2016

Type of proposed intervention: Conservation works

Works will start within **2017**

The original building of the mosque at the Mouttalos area of Ktima-Paphos, had been a Christian Orthodox Church and it is still referred to as the church of Agia Sofia. In the 16th century part of the church had been destroyed. The central aisle of the church was later rebuilt. This is one of Paphos's most important Byzantine monuments, estimated to have been built in the 15th century as a three-aisled, cross-in-square, domed church, which was converted into a mosque in the years of Ottoman period (1571-1878). In 1894 the minaret had been struck by lightning, which rendered its condition dangerous. In 1900, it was demolished and rebuilt. Further repairs became necessary after the earthquake of 1953 and were undertaken during the years 1954 to 1956. During the years 2009-2012, preservation works have been conducted on the monument.

A study & condition assessment was commissioned by the Technical Committee on Cultural Heritage through UNDP between November 2015 and February 2016.

Proposed interventions for this monument comprise, among others:

- Structural consolidation of the Minaret and its base
- Approximately 35-40 stones which are in quite poor condition are to be removed and replaced throughout the entire surface of the Minaret base.
- Repair eroded stairs of the Minaret, where rendered necessary.
- The core of the stone staircase will be repaired
- Rubble and mortar joints from the balcony until the metallic cone the minaret will be repaired.
- Repair of the balcony
- All joints of the balcony floor stones will be cleaned and repointed
- Repointing and rejointing will be applied.
- All cement jointing and all plaster will be removed and replaced.
- The metal cone at the top of the Minaret will be repaired or replaced. Lightning Protection on the top of the Minaret will be installed.
- Regular monitoring of the Minaret's inclination

Conservation works are planned to start and to be completed within 2017. The project is fully funded by the **European Union**.
